Our financial counselors are on staff and available to answer any specific billing questions. The following information is provided as a courtesy to clarify your financial responsibility related to professional services provided by Virginia Prosthetics. This document does not cover all situations and should not be construed to be an all-inclusive listing of possible situations. If a specific payer contract (including Medicaid, VA and Worker's Comp) is in conflict with any of the policies below, then the payer contract will supersede the conflicting policies. As part of our commitment of service to you, we will make every attempt to verify your insurance benefits at the time your services are rendered. However, insurance verification or authorization is not a guarantee of insurance payment. This only allows our office to provide you with a preliminary estimate of any monies due by the insured at the time of delivery of the device or service. Your patient portion is subject to change based on a final claim determination by your insurance carrier.

What Is My Financial Responsibility for Services? Your financial responsibility depends on a variety of factors, explained below.

Medicare Part B	<p><u>If you have Medicare Part B,</u> and have not met your deductible, we ask that it be paid on or before date of delivery.</p> <p><u>If you do not have a secondary insurance.</u> Medicare co-insurance amount on or before the date of delivery.</p> <p><u>If the total services are less than \$250.</u> Full payment on or before the date of delivery.</p> <p><u>Payment for any services not covered by Medicare.</u> Full payment on or before the date of delivery.</p>	<p>Contact Medicare and secondary insurance plan (if applicable) to obtain your eligibility and benefit information.</p> <p>Submit your insurance claims to your secondary insurance.</p>
Medicaid	<p><u>Depending on each state's Medicaid program, if the services you receive are covered by Medicaid:</u> patient portion (if applicable) on or before date of delivery.</p> <p>Payment for any services not covered by Medicaid. Full payment on or before date of service.</p>	<p>Contact local Medicaid office to obtain your eligibility, benefit information and patient portion (if applicable) as well as obtain prior authorization (if applicable).</p>
Worker's Comp	<p><u>If the services you receive are covered by Worker's Comp:</u> patient portion on or before date of delivery.</p> <p>Payment for any services not authorized by Worker's Comp on or before the date of delivery.</p>	<p>Call your Worker's Comp plan to obtain your eligibility, benefit information and patient portion (if applicable) as well as obtain prior authorization (if applicable).</p>
No Insurance	<p>Payment in full on or before the date of delivery.</p>	<p>Advise you regarding charges for services provided.</p>
